October is National Cyber Security Month



Helpful tips for helping to keep your identity, personal information and data secure. More information on these topics and more can be found on the pages linked at the bottom of the page.

Phishing Emails

- Never respond to requests for personal information via email. Businesses will never ask for personal information in an email.
- Do not enter personal information in a pop-up screen.
- Do not click on any links listed in an e-mail message. Copy and paste the URL into your browser.
- Use anti-virus and anti-spyware software and update them regularly.

Dispose of Information Properly

- Destroy/shred hard copy confidential documents that contain personal information such as social security numbers, credit card numbers, bank account numbers, health records.
- Ensure you are using the right tools when destroying and disposing of personal information or media storage from your computer and mobile devices.

Ethics - Be a good cyber citizen

- Do not engage in inappropriate conduct, such as cyberbullying, cyberstalking or rude and offensive behavior.
- Do not do something in cyberspace that you would consider wrong or illegal in everyday life.
- Do not impersonate someone else. It is wrong to create sites, pages, or posts that seem to come from someone else.
- Adhere to copyright restrictions when downloading material from the Internet.
- Do not use someone else's password or other identifying information.

Lock it when you leave

- It takes only a few seconds to secure your computer and help protect it from unauthorized access. Lock down your computer every time you leave your desk.
- Set up a screen-saver that will lock your computer after a pre-set amount of time and require a password to log back in.
- If your computer is used by more than one person, your may want to create individual accounts, with unique login and passwords for each user.
- Choose a strong password. A good password should always include upper and lowercase letters, numbers, and at least one special character. Do not set the option that allows a computer to remember any password.

Protect data on mobile devices

- Ask yourself "Is it really necessary that I transport this sensitive information?" If the answer is no, then do not copy the information.
- Choose a strong password. A good password should always include upper and lowercase letters, numbers, and at least one special character. Never use the same password for multiple devices or accounts.
- Store your portable devices securely. When not in use, store devices out of sight and when possible in a locked drawer or cabinet.

Protect mobile devices

- Password-protect your portable device.
- Be sure all critical information is backed up.
- Disable Bluetooth when not required.
- Make sure your firewall and anti-virus are up-to-date.
- Store your portable devices securely.
- Record identifying information such as serial number and label your equipment if possible.

New California law helps utilities with wildfire lawsuits

Gov. Jerry Brown signed a measure Friday allowing utilities to bill their customers to pay for future legal settlements stemming from devastating 2017 wildfires, even if the blazes are blamed on the company's mismanagement. The bill is aimed at preventing bankruptcy or other serious financial trouble for Pacific Gas & Electric Co. The nation's largest utility by revenue faces billions of dollars in liability if investigators determine its equipment caused the Tubbs Fire that destroyed thousands of homes and killed 22 people in Santa Rosa last year. "Wildfires in California aren't going away, and we have to do everything possible to prevent them," Brown said in a statement. "This bill is complex and requires investment - but it's absolutely necessary. "Critics call it a bailout for PG&E investors. The bill creates a special process for the 2017 fires, which caused more than \$10 billion in insured losses, by far the most in state history. It seeks to determine how much liability the utility can absorb without triggering severe consequences like bankruptcy, and allows any additional costs to be billed to consumers. For fires sparked in the future, the bill allows the Public Utilities Commission to consider a variety of factors — including weather conditions, a utility's efforts to prevent fires and findings of mismanagement — to decide whether electric companies can pass costs to consumers. The utility protections are part of more than two dozen bills Brown signed to reduce the risk of wildfires, including efforts to make it easier to conduct controlled burns that aim to clear out dry vegetation that would fuel wildfires. PG&E is facing dozens of lawsuits from insurers, which have spent billions settling insurance claims from homeowners. Courts have ruled that utilities are entirely liable for damage caused by their equipment, even the utility followed all safety precautions. Regulators have required utility investors to shoulder the legal burden for fires caused by mismanagement of electrical equipment. Brown proposed eliminating that standard, known as inverse condemnation, but lawmakers dropped the idea amid pressure from insurers, trial lawyers and fire victims. Despite the legislation, Moody's Investors Service downgraded the credit ratings for California's three big

investor-owned utilities. PG&E and its parent company were just above junk bond status. Moody's analyst Jeff Cassella said the legislation represented "extraordinary legislative intervention" but failed to rollback inverse combination. If PG&E is blamed for the most destructive fires and passes along costs to customers, they'll appear as a surcharge on monthly utility bills for the next 20 years. The cost is unknown because it's not clear which fires will ultimately be linked to PG&E, what its final settlement will look like or how much of the burden will be placed on investors. Sen. Bill Dodd, a key negotiator, said the average residential ratepayer would pay an estimated \$5.20 extra for every \$1 billion dollars that PG&E must finance. In the second quarter of this year, PG&E spent more on lobbying in California than any other entity, records show. It dropped more than \$1.7 million, nearly three times as much as it spent the previous quarter, most of it on wildfire issues. Up from the Ashes, a group representing trial lawyers and people who lost homes in the fire, spent more than half a million dollars. The measure is the most hotly contested part of a wide-ranging plan to reduce the threat of wildfires, which have been larger and more destructive in recent years. The bill also requires investor-owned utilities — including PG&E, Southern California Edison and San Diego Gas & Electric — to harden their equipment so it's less likely to cause fires. It would make it easier, in some circumstances, to do prescribed burns, clear dead trees and brush, log trees and build fire breaks. It includes \$1 billion over the next five years for those purposes. Among the other bills Brown signed is a measure aiming to triple the amount of land in California treated with prescribed burns and to limit liability for private landowners conducting controlled burns on their property. The bill helps clarify that landowners who get a permit to conduct a prescribed burn and comply with its terms have done their due diligence."These private landowners were afraid to get permits because they were afraid of getting sued if something happened," Sen. Hannah-Beth Jackson, a Santa Barbara Democrat who wrote the bill, told media during a conference call earlier this year. Brown also signed bills to maintain insurance coverage following disasters, improve emergency notifications and to require that garage door openers have a battery backup so people can get their cars out even if the power goes out.

HOW TO KEEP THE CAR KEYS

When it comes to staying safe on the road, this is a GOOD time to be an older driver. The number of people 70 and older killed in crashes has decreased by 18% in the last 2 decades to 4792 deaths in 2016, according to the Insurance Institute for Highway Safety (IIHS). And today's older drivers are involved in fewer crashes per mile traveled than those in prior generations.

These positive trends come as the number of drivers who are 70 and older is increasing. One reason for fewer fatalities: vehicles are safer than ever. "Side airbags have been standard on the majority of new vehicles the 2008 model year and we are seeing the benefits of improved side-impact protection in the crash data, especially for older drivers," says Jessica Cicchino, IIHS vice president for research. "Today's older drivers are walking away from crashes that might have killed their grandparents."

Simply getting older shouldn't affect your safety and fitness to drive. Many older drivers enjoy better health than drivers who were the same age decades ago, so they can function more safely today, and for a longer time.

READ THE WARNING SIGNS: Still, a time may come when you'll need to consider giving up the keys. Many chronic health conditions can compromise driving skills, from the obvious culprits like cataracts, arthritis, Alzheimer's disease and sleep apnea, to the less—obvious ones (diabetes, for example, if your blood sugar levels suddenly dip).

So how do you know if it's time? **HERE ARE 5 QUESTIONS TO ASK** yourself-or a loved one you are concerned about-to assess whether it OK to stay behind the wheel:

Do you frequently have difficulty reading street signs and seeing street markings?

Does driving leave you feeling anxious and stressed?

Have friends or family members expressed concern regarding your driving, or said they don't feel safe with you behind the wheel?

Do you have difficulty with certain physical requirements of driving? For example, do you have trouble looking over your shoulder when changing lanes?

Are you currently taking medication that causes drowsiness or otherwise impedes your ability to drive?

If you answered YES to any of these questions, AND you want to keep driving, consider these steps:

RETHINK YOUR MEDS: many medications can make you drowsy or affect your concentration. Your doctor may be able to suggest a drug without those side effects. Your doctor may also give your certain driving restrictions- such as avoiding night driving or curvy country roads -that can keep you out of potentially dangerous situations. Doctors are getting some training on this topic. The National Highway Traffic Safety Administration and the American Geriatric Society teamed up to publish the Clinician's Guide to Assessing and Counseling Older Drivers. The study found that many older drivers successfully self-regulate their driving after it becomes clear that restrictions are warranted.

GET A CONSULTANT: They're called driver rehabilitation specialists, and they help if you're becoming anxious or uncertain about your ability to pilot a vehicle. A specialist will access your abilities and offer advice to help you drive more safely. For example, he or she might suggest vehicle modifications that could help make your time behind the wheel less physically taxing. Many specialists offer discounts to seniors, and your health insurance may cover part or all of the evaluation.


TAKE A COURSE: Today's driving environment is vastly different from when you first got licensed. New laws (such as those designed to prevent distracted driving) and new technologies are part of the equation. A course geared to older drivers can help you navigate this ever- changing landscape. AARP offers several of these courses all across the nation (aarp.org/drive). Participants in a senior driving course could qualify for a car insurance discount.


UPGRADE YOUR CAR: The IIHS has identified several technology upgrades that reduce crashes for older drivers: rearview cameras that can help drivers see while backing up; automatic emergency braking systems; collision warning systems; and blind spot and lane-departure warning systems that help avoid crashes while changing lanes.




